It will address the lack of access to land for livelihoods and promote environmentally friendly and climate-positive land management practices. A recent report commissioned by the Crofting Commission revealed that for every £1 of economic impact directly added by crofting, it generates £19 in indirect benefits. Crofting overall contributes £588 million annually to the national economy.

Woodland crofts, which extend and combine the crofting model with forestry and woodland management, could be an innovative approach to solving a range of issues faced by the Morvern community. For instance, in Lochaline, where approximately 90% of the land surrounding the village is under forestry, woodland crofts could provide a solution.

Morvern Community Woodlands is proposing to purchase 93 hectares of forestry land from Forestry and Land Scotland. This land, which will be used for crofting, local timber and firewood production, will also become an important area for recreation. Native trees will be planted to care for the land. Paths that were lost during recent felling work will be replaced, and a link path will be created between the new settlement around Achnaha and Lochaline village. The project has the support of the local community, as evidenced by the overwhelmingly positive responses in the Local Place Plan. Morvern Community Development Company, known for its successful projects locally, will be a partner in the project.

Morvern Community Woodlands are now applying to the Scottish Land Fund through the Community Asset Transfer Scheme to purchase the land. This exciting project, Lochaline Community Forest, will benefit the local community and beyond. Morvern Community Council are therefore excited to extend our support to the project as it progresses.

Morvern Community Development Company (MCDC) is pleased to confirm our commitment to supporting Morvern Community Woodlands (MCW) in the successful establishment and development of the Lochaline Community Forest.

Following the anticipated community acquisition of the woodland site, MCDC pledges financial and in-kind support for a **part-time Project Development Officer** post for a period of one year, beginning from the date of transfer. This commitment includes:

- If funding cannot be secured from other sources (such as MCT) a cash contribution of £14,000 toward the salary of the post (equivalent to 2 days per week over 12 months) from March 2026
- In-kind line management, financial and commercial and administrative oversight, to be provided by the MCDC operations manager.

This role will be vital in coordinating woodland development activities, supporting croft and enterprise planning, overseeing community engagement, and helping secure future funding.

In return for this support, MCDC and its affiliated social enterprise, **MorVolts**, will be granted **first right of refusal on any renewable energy generation opportunities** arising on the site post-acquisition with the exception of domestic generation in relation to croft housing, holiday houses/cabins or accommodation for rent on the proposed site. This would include up to full build and operation rights with, in return, a suitable market value rental paid to MCW for the land.

We look forward to continuing to work in close partnership with MCW to ensure the success of this transformational community project.


