This Decision Notice relates to the asset transfer request made by AVIEMORE AND GLENMORE COMMUNITY TRUST on 7 January 2024 in relation to the Glenmore Visitor Centre and Car Park, Glenmore, Aviemore shown on the indicative plan annexed, "the disposal area".

Forestry and Land Scotland has decided to agree to the request.

The reasons for this decision are as follows:

- AGCT's proposal demonstrates the potential to increase community and public benefit through community ownership of the Glenmore Visitor Centre and Café and positively engage the community as a key partner to support sustainable tourism in Glenmore.
- FLS welcomes the commitment by AGCT to work with FLS and CNPA to further develop
  the Glenmore visitor experience, through outdoor education, interpretation facilities,
  sustainable transport, and modern facilities.

- AGCT has demonstrated substantial community support through community consultation during the development of their request for the Glenmore Visitor Centre and from the representations received from key stakeholders including local residents, public bodies, and local businesses.
- AGCT has responded to the representations received and advice from the CATS Evaluation Panel to help strengthen their business case. AGCT has confirmed that they are being advised by a qualified consultant and independent business individuals with expertise in tourism and the food and drink sectors, are engaging with relevant funding bodies and are reviewing the financial projections to strengthen the business plan.
- AGCT has provided a Glenmore Recruitment and Retention Plan, which commits AGCT to be a Living Wage employer and to engage in the Transfer of Undertakings Protection of Employment (TUPE) process to rights and job security for existing staff are protected. AGCT has set out its Equality, Diversity and Inclusion Policy, committing to encourage equality, diversity, and inclusion among their workforce, and eliminate unlawful discrimination.
- FLS recognises the importance of the site to the Aviemore and Glenmore community, and as a key visitor attraction for the surrounding Glenmore Forest Park. FLS has therefore agreed with AGCT that the terms and condition of the transfer will include a right of preemption to mitigate the risk that the site could be transferred in future other than to FLS or another appropriate community body.
- AGCT and FLS jointly instructed a market valuation of the site and FLS has accepted the price offered by AGCT which is the full market valuation.

The attached document specifies the terms and conditions subject to which we would be prepared to transfer ownership of the land to you. If you wish to proceed, you must submit an offer to us at the address above by 30 September 2024. The offer must reflect the terms and conditions attached, and may include such other reasonable terms and conditions as are necessary or expedient to secure the transfer within a reasonable time.

## Right to appeal

If you consider that the terms and conditions attached differ to a significant extent from those specified in your request, you may appeal to the Scottish Ministers.

Any appeal must be made in writing **by 24 April 2024**, which is 20 working days from the date of this notice, to:
