This request seeks approval to include several windblown management coupes of mainly Sitka spruce and Japanese larch within phase one of the Pitmedden and Weddersby Land Management Plan.

For the Purpose of this amendment, the affected windblown coupes have been combined into new management coupes as outlined below:

Please note that the restock coupes have changed shape in line with the above table but the restock prescription has remained consistent with the approved Land Management Plan.

These areas have suffered significant windblow over the past 12 months and now pose a risk to the public, particularly given the high levels of footfall and recreational use in the surrounding area. Several of the affected coupes are also located alongside a forest road right of way that experiences regular vehicular use by members of the public.

Clearing the windblown timber will enable the recovery and sale of the affected crop. Several areas of standing timber have been included to facilitate harvesting and extraction operations and to ensure that encroaching windblow is brought to a windfirm edge.

European Protected species Great Crested Newt (GCN).	GCN Breeding Pond in vicinity to 58034 . Conservation impact zone overlaps 6.01 hectares of proposed felling.	Environmental Forester investigated site – Under Special area of Conservation (SAC) guidance - work area does not exceed 25% of 250m conservation impact zone of GCN breeding pond and does not require specific consent. All harvesting operations will be in compliance with Forestry Commission Guidance Note 35b Forest Operations and Great Crested Newts in Scotland.

Private Water Supply point in proximity to 58036	50m buffer round PWS and 5m buffer to any infrastructure.	In addition to meeting the UK Forestry Standard (UKFS) and Forests and Water Guidelines, the "Guidance on Forestry Activities Near Private water supplies" will be considered also.
High recreational forest	Lots of recreational use in the forest by local community. MTB trails throughout forest.	Thorough consultation with local authorities and residents. Consultation with Tayside Trail Association to protect assets.
Public right of way on forest road.	Public right of way and Consultation Timber Route for extraction.	No timber stacking on right of way, public road management. Consultation timber routes are key to timber extraction but, for a variety of reasons, are not up to Agreed Route Standard. Consultation with the Local Authority is required before any timber haulage takes place and it may be necessary to limit the amount, timing or frequency of timber haulage, or to specify lower impact vehicles to prevent damage.
