### Glenmore Visitor Centre Asset Transfer Survey June 2023

Aviernore & Glenmore Community Trust (AGCT) wish to make an application for Community Asset Transfer (CAT) for the lease and eventually the purchase of the Forestry and Land Scotland (FLS) Glenmore Visitor Centre building, land and car parks.

- Enhancing the cafe offering, increasing opening times and encouraging visitors to spend more time at the centre
- Develop a space for events/talks/workshops for use by school, special interest and community groups
- To create local employment and training opportunities
- To develop strong partnerships between key stakeholders and community to create a unified approach to visitor management and to support responsible tourism and environmental protection messaging
- To allow income generation to be reinvested into the visitor centre and local community

AGCT would like to develop a Glenmore Heritage Centre telling the incredibily rich history of Glenmore, which would include:-

- The story of past Glenmore communities and industries
- The WW2 Norwegian Resistance Fighters who trained in Glenmore
- The role of the Forestry Commission in developing Glenmore Forest Park
- The environmental qualities of the Glenmore forest and its wildlife
- The development of the Glenmore area for outdoor sport and recreation





Would you support AGCT to lease/own the Glenmore Visitor Centre on behalf of the community? 161 responses




Would you support the development of the Visitor Centre to include a Glenmore Heritage Centre to tell the incredibly rich history of the Glenmore area?






Please tick Visitor Centre improvements, additions you would support?



#### Do you think the Visitor Centre cafe offering could be enhanced?








If cafe opening hours were to be expanded, what time of day would you be most likely visit?



### How often would you visit the Glenmore Cafe?




# Car parking: Would you like to see better management of the Visitor Centre car park? 150 responses




Would you support wider community ownership for the Glenmore Visitor Services areas?




#### Where do you live?
