

Summary of Land Management Plan **Proposals**

The Minniwick Land Management unit comprises of a single forest block neighboring the villages of Bargrennan and Loch Trool. Covering 700.1 ha, the management unit is located around 10 km to the north west of Newton Stewart, Dumfries and Galloway, South Scotland. It is part of Scotland's national forests and land, owned by Scottish Ministers on behalf of the people of Scotland, and managed by Forestry and Land Scotland (FLS).

The Minniwick Land Management Plan (LMP) defines the management prescriptions for the next ten years (2023-33), and presents the vision for the long-term management of the area. The main management objectives in this plan focus on sustainable low impact timber production, management of ancient woodland sites, and water quality.

Critical Success Factors

- Increased use of alternative to clearfell management practices.
- Management of spruce in low impact management areas, ancient woodland areas and riparian zones.
- Creation of access provisions for affective deer management.
- Resources committed to re-generation removal to maintain open areas.
- Fell years to be kept as priority in Acid Sensitive Catchment areas.
