Our response to those who voted against the transfer

Dear...,

You recently responded to a poll run by us (Heart of Argyll Wildlife) where you indicated that you were not in favour of us seeking an asset transfer to take over ownership of our centre from Forestry and Land Scotland (FLS). As part of the process we have been asked by FLS to establish why you are opposed.

We'd be grateful if you could let us know and we will submit your thoughts (anonymously) along with the rest of the information we have to provide. If you have any questions about the process we will be happy to answer these for you.

Responses to the above question

1. There is no requirement from my position for you to keep my reply anonymous, I really don't have anything to hide, please feel free to share my name and feedback with FLS.

I have lived in Cairnbaan since late 1988. Part of the reason for choosing to move my job and family to Cairnbaan was the undiscovered nature of the location, the peace and quiet and the rural lifestyle and up until about 10 years ago this was the status quo. Over the past few years there now seems to be an abundance of tourists with an increased range of visitor attractions, including your centre-ranging from mobile coffee shops to fast boat trips / regular events, expansion or conversion of wild paths to marked walks and cycle tracks and routes involving Sustrans and others. The knock-on effect of this is that on numerous occasions, it can be impossible to have a peaceful walk in my own local area - or a cycle without being in the crowds, Mid Argyll has lost the balance of preserving the area for people who actually live here and I feel the focus is more on attracting visitors and tourists, this is wrong in my opinion.

Specifically, with your asset transfer, this gives you additional freedoms to expand and adapt for your own purposes which do not match my wishes for Mid Argyll which has been my home for the past 31 years. Having walked past 'your centre' in 1990 - I would never meet a single person, nowadays it's not possible to have a walk to the viewpoint without dodging bikes , cars or people - or actually find a place to park - it is my strong opinion that your development including asset transfer from FLS contributes to these issues and is very detrimental to my own preferences and the more freedom = your control that you will have with this asset - and this will only make Mid Argyll worse from my position. It will provide your organisation via the centre and immediate area with too much control. It will no longer be publicly owned / not part of Scotland's central government belonging in theory to the public of Scotland - there will be less recourse available for myself and others to make future objections to any use or development or expansion plans - you may have now or in the future.

I have witnessed previous similar asset transfer to community or third sector group control with other situations and locations in Mid Argyll, e.g Tayvallich, Crinan , and it seriously concerns me that places I once had access to I am now either prevented from using , or I am charged to use , its not acceptable and I do not support this asset transfer to your organisation by FLS and I strongly disagree with this.

Thank you for the opportunity to provide further comment concerning my original response opposing this.

2. My main objection is the taking over of an asset which belongs to the people of Scotland as do the forests under the management of FLS. All off the assets and forests are free for all to use at any time and benefit peoples' health and well-being. In my opinion it is a gradual creeping extension by FLS to dispose of the national forest estate as attempting to sell off the two largest districts years ago ended in a total disaster. The whole estate should remain in public hands and at no point should any group be charging people to see wildlife in our forests. Past projects have already cost the taxpayer a six -figure sum plus in maintenance, repairs, structures, and damage to our forests.


